RELEASE AND WAIVER OF LIABILITY

THIS RELEASE AND WAIVER OF LIABILITY (THE “Release”) is executed this ____ day of _____, 20__ by the undersigned (the “**Volunteer**”), in favor of Habitat for Humanity of Palm Beach County, a Florida not-for-profit corporation (“**Habitat**”), its directors, officers and agents. Volunteer does hereby freely, voluntarily, and without duress execute this Release under the following terms and conditions:

- 1. WAIVER AND RELEASE.** Volunteer does hereby release and forever discharge and hold harmless Habitat and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, whether in law or in equity, which arise or may hereafter arise from Volunteer’s participation with Habitat. Volunteer understands this Release discharges Habitat from any liability or claim that Volunteer may have against Habitat with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer’s participation and financial assistance or other assistance, including but not limited to medical, health, or disability insurance. Volunteer is encouraged to have medical or health insurance in effect.
- 2. MEDICAL TREATMENT.** Volunteer does hereby release and forever discharge Habitat from any claim whatsoever which arises or may hereafter arise on account of first aid treatment or service rendered in connection with the Volunteer’s participation.
- 3. ASSUMPTION OF RISK.** Volunteer understands that Volunteer’s participation with habitat may include activities that may be hazardous to the Volunteer and that food, tools, supplies and facilities may be donated to Habitat and beyond the control of Habitat. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases Habitat from all liability for injury, illness, death or property damage resulting from the activated of Volunteer’s participation with Habitat.
- 4. PHOTOGRAPHIC RELEASE.** I grant and convey unto Habitat all right, title, and interest in any and all photographic images and video or audio recordings made by Habitat during my work for Habitat, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- 5. OTHER.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Florida. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
